YEARS OF INJUSTICE, DISCRIMINATION AND RACISM THAT HAVE BEEN FELT BY PEOPLE OF COLOR FOR GENERATIONS HAD REACHED ANOTHER BOILING POINT IN 2020 WHEN FOUR MINNEAPOLIS POLICE OFFICERS WERE INVOLVED IN THE MEMORIAL DAY KILLING OF GEORGE FLOYD. P&TC VALUES INCLUSIVENESS AND BELIEVES THAT THE BENEFITS PARKS AND TRAILS PROVIDE SHOULD BE AVAILABLE TO EVERYONE, BUT THIS CANNOT HAPPEN WHEN PEOPLE OF COLOR ARE TREATED UNJUSTLY.

IN 2020, P&TC COMMITTED TO RECKONING WITH ISSUES WE'VE KNOWN ABOUT FOR YEARS. SPECIFICALLY, WHAT CAN WE DO TO BE MORE INCLUSIVE IN ENSURING THAT THE WORK WE ARE DOING BENEFITS BLACK, INDIGENOUS AND PEOPLE OF
