

Friends Group Partners Impact: Full Report 2020

In an effort to better understand the impact that friends groups have on Minnesota's parks and trails, Parks & Trails Council (P&TC) surveyed our friends group partners about their activities from calendar year 2020 (Jan.-Dec.). The data collected offers unique insight into the structure and function of friends groups. This report helps provide context to our friends group partners about the greater friends group landscape and offers details about specific functions, including members and volunteers, outreach, events and projects, and financials.

Members

There are two main groups of people that are involved in friends groups: members and volunteers. For some friends groups, members and volunteers are one and the same; for others, members and volunteers are two distinct groups.

Not all friends groups track membership and each group has their definition of membership. A common theme among groups that track membership is that members are any person, business, or entity that has contributed money and/or time to the group's efforts. Some groups have a formal membership program where they collect annual dues (ranging from \$5 per individual to \$500 for a lifetime membership) while other groups maintain a more informal membership.



Word cloud based on Friends Group Partners' definitions of "member"




Membership tracking

% of Friends Group Partners with _____ members




Volunteers

Volunteers play a crucial role in friends groups, as they lead, contribute to, and carry out all of the group's activities. Volunteers are defined as anyone that contributed time and talent in support of the friends group. For most groups, volunteers are considered members, but not all members are considered volunteers.


Number of volunteers

% of Friends Group Partners who engaged _____ volunteers




Volunteer hours

This is equivalent to \$205.50 worth of volunteer hours


The value that volunteers provide is hard to quantify, but they undoubtedly make an impact. While some folks contribute money to friends groups, time is also an incredibly valuable contribution.




Events and projects
