

Exciting Glendalough Projects are in Motion

On May 13th, the long-term planning committee of Glendalough Citizens Advisory Board (CAB) met via Zoom conference with staff members of the Minnesota DNR to discuss two important projects underway in Glendalough - the Sunset Lake Trail and the new Visitor Center. We are excited to report that both projects have experienced significant traction and funding!

Ben Bergey, DNR Northwest Regional Parks Manager led the call with support from Erik Wrede, the DNR project consultant on numerous projects statewide. They provided updates and facilitated discussion on both projects with the planning committee members Steve Nelson, Joan Vorderbruggen, Peter Christianson, and Dan Malmstrom, along with our DNR team members Jeff Wiersma and Shawn Donais.

Bergey reported the Sunset Lake Trail has been fully funded

with \$975,000 of state and federal grants that were supported with matching funds from Glendalough Park Partners. This trail segment will run from the park entrance at County Highway #16 and meet up with the existing paved trail at the Annie Battle Lake bridge. It will traverse the prairie grasslands west of the park road to Sunset Lake, with its final section intersecting the new Visitor Center. This project is queued to begin sometime in the DNR's fiscal year 2022 which runs

Rasmusson Committed to Glendalough by Dan Malmstrom

Over the years, Glendalough Park Partners has enjoyed great relationships with our state lawmakers, and it appears that tradition will continue with Jordan Rasmusson. A year ago long-time State Representative - and Glendalough advocate - Bud Nornes decided to not seek re-election. In his departure, Bud endorsed another Otter Tail County professional, Jordan Rasmusson. Jordan won the vacated spot in the 2020 election.

Nornes had represented Glendalough so well over the years. A few examples include teaming up with Senator Dan Skogen and Governor Tim Pawlenty to influence 2010 bonding for the Glendalough Trail loop. In 2018, he worked with Senator Ingebrigtsen



and the Park Partners to influence bonding for our new visitor center. Not only was Bud a strong advocate for Glendalough in St. Paul, but you would often see him at the annual Walk for Glendalough. A true Park Partner.

Rasmusson seems enthused to follow in Bud's tradition as he was one of the very first people to show up for the 2021 Walk on April 24th. Jordan recently attended the Citizens Advisory Board meeting on May 20th to become acquainted with the board and its many important projects in motion with the DNR.

As a first term State Representative, Jordan is wellequipped to represent our area. He knows Otter Tail County as a sixth generation Rasmusson. Jordan graduated from Fergus Falls High School and went on to receive his B.A. in Government at Harvard. Subsequently, he had career stops at McKinsey Consulting and Bain Capital. He currently volunteers as a board member at the Fergus Falls YMCA and the Otter Tail County Historical Society. Jordan and his wife Emma reside in Fergus Falls.

We welcome Jordan to the Park Partners team and look forward to his collaboration as he joins our influence and stewardship toward Glendalough.

Media Experience GSP at Governor's Event

Our team stood ready on Friday, May 14th as media from across the state of Minnesota descended on Glendalough State Park. A team of Park Partner volunteers and park management had prepared several months in anticipation of the Governor's Fishing Opener held in Otter Tail County in 2021. Erik Osberg from Otter Tail County and Val Martin from the City of Battle Lake led the planning efforts as Battle Lake and Glendalough were featured destinations.

Volunteers were stationed in downtown Battle Lake, and at the park entrance kiosk, Galloping Goose, Lodge and the yurts to provide our guests with information, services and local hospitality.

Although the governor did not visit Glendalough State Park, we were fortunate to have the DNR Commissioner visit early Friday morning. Sarah Strommen and members of her team hiked from the Molly Stark shelter across the Annie Battle hiking bridge and made their way to visit the popular Glendalough yurts.

A steady flow of media and the public began to arrive in the park throughout the day. It's estimated that more than 20 media professionals ranging from social media sites, publications, and radio personalities from as far north as Warroad and south to Austin were experiencing Glendalough for the first time.

One of my favorite moments was biking through Glendalough State park. Everything is so green and vibrant. And the smell of the freshly growing grass was palpable".

All the volunteers did an exceptional job describing Glendalough's history, heritage fishery, array of unique attributes, and growing popularity as a primitively managed state park. One media fishing duo from Minnetonka – after receiving some tips at the Galloping Goose – boarded a canoe and experienced the incredible Annie Battle Lake black crappie bite first-hand.

from July 1st, 2021 to June 30, 2022. This is an exciting development for park visitors as it completes the 12-mile bike and pedestrian trail loop, making the trail completely off-road from the City of Battle Lake and school to Glendalough. Families, students, bikers, hikers, and roller blade enthusiasts will be thrilled with this new segment that unifies all previous trail projects.

Bergey then presented two design options for the new Visitor Center. The Visitor Center project is in the design refinement phase and is a very promising addition to Glendalough as well. (see second option below)

The CAB planning committee offered feedback and questions to ensure the final design would align with the original trail center plan we developed and presented to the DNR and Senate during the successful 2018 bonding process. The dialogue was very useful.

Either of the Visitor Center options would be great additions to Glendalough; however the CAB believes a variation of the second design option will better serve the growing number of visitors and students visiting the park. (127,000 visitors in 2021 and up from less than 50,000 in 2014). A variant of the second option would provide more interpretive and educational space, along with sufficient rental square footage for the park concessionaire.

At this writing, the DNR believes preliminary cost estimates for the complete plan will be in excess of \$2,000,000. Further refinements will be made to the design plans along with a determination of DNR internal funding sources. Funding raised for this project currently stands at approximately \$1,250,000 – a combination of \$750,000 of 2018 state bonding, \$250,000 of Legacy Grant funds, and more than \$200,000 of philanthropy raised by Park Partners. We will consider a capital campaign, if needed, once the design, plans and costs for the new Visitor Center are finalized. In the meantime, the local Park Partners board continues to enjoy a great working relationship with the DNR in our mutual stewardship toward the park. These two projects are the newest examples of our effective partnership spanning nearly 30 years at Glendalough.

Statewide Scavenger Hunt Includes Glendalough State Park by Sarah Govig

Beginning June 1, visitors to Glendalough State Park – and many parks around the state – will participate in a statewide Scavenger Hunt sponsored by the Parks & Trail Council of Minnesota. A tailored checklist has been created for each park, including Glendalough. The checklist includes 20 items in five categories (Mammals, Flowers, Trees, Humans and Birds) to showcase the diversity of life within our park.

Glendalough Park Partners is a member of the Parks & Trail Council of Minnesota and we are thrilled to offer this Scavenger Hunt to our membership. The summer event is open to park goers of all ages, with weekly drawings for \$20 gift cards.

beginning in the early 1990s. Without owning a grain of sand on any of its lakes, they have made Glendalough "their own" in so many ways.

In the February 2020 issue of Tracks & Trails, you were briefly introduced to Steve and Diane Christianson, formerly of Fergus Falls. They were killed in a tragic car accident last year. Over the years, I had heard stories about Steve from a mutual friend, and his passion for fly-fishing muskies among the northern islands of Lake of the Woods but had never heard of his Glendalough experiences.

I set out to learn more. Fortunately, Steve and Diane's grown children have nearly 30 years of Glendalough memories. You see, Steve and Diane chose to enjoy Glendalough during all seasons, every year. Their children speak the language of Glendalough's public experiences.

Their son Trevor expresses it so well. "I recall asking my parents a few times over the years why they never bought a lake cabin. I remember my Dad saying something like 'we have access to thousands of lakes already'. As my brother Titus and I were growing up, our family visited dozens of lakes in Otter Tail County. I remember a couple summer days in the 1980s when we tried to see how many lakes we could swim in one day. Once Glendalough became a State Park, our parents must have been among the first to "discover" it. Glendalough quickly became our favorite lake place.

I remember holding my Dad's hand as a young boy while snorkeling. Since the early 1990s, snorkeling has been my favorite activity at Glendalough. Last July, three generations of our family snorkeled together in the creek between Molly Stark and Annie Battle. Both of my parents, my seven-year-old son Thomas, and me exploring together. I think we met my parents at Glendalough about 10 times last summer, the last occasion being on Labor Day weekend. During one of their last visits to Glendalough, sometime in mid-September, Dad caught a bass while fly fishing, and a huge muskie attacked the bass and broke his fly rod. Chuck, dad's brother, shared the details of this Glendalough story for the funeral guests. We were blessed with so many good times at Glendalough with my parents over the past 25+ years."

Due to the commitment of the Minnesota DNR and Glendalough Park Partners, the park has been developed with a sensible balance of public amenities while preserving the simple, primitive experiences that are fundamental to Glendalough. You can feel the harmony of those simple pleasures in the Christianson memories.

Their daughter-in-law Melinda reflects, "Steve and Diane spent countless days at Glendalough, enjoying each season there. They cross country skied in the winter and took in the fall foliage – which Steve documented with thousands of photos. I would argue that summer was their favorite season due to fishing, biking, and spending time on the beach with their family and friends. Steve was often wading in Annie Battle Lake to fly fish and loved having his grandsons fishing alongside. Diane was happy to play with the boys in the sand or take a tired child for a stroller walk on the bike trail. They packed more than enough food for picnics – no one would go hungry! Our favorite spot was a picnic table near the lodge."

As we imagine Steve and Diane experiencing Glendalough from its fledgling beginning, we understand their appreciation for the amenities to support public experiences while keeping Glendalough pristine and primitive. Families can now enjoy enhancements like new and renovated facilities, picnic areas, restrooms, showers, trails, rentals, camping, yurts, and much more.

Although Steve and Diane's time in Glendalough has faded into one of the park's beautiful sunsets, their legacy of experience and stewardship remains. Katy (daughter-inlaw) reminisces, "I can picture Steve in his faded turquoise sun shirt at a picnic table preparing his fishing tackle while Diane gently swings a grandson in a hammock nearby. And then there's Steve engaged in a water fight with all the boys and Diane laughing as she gets caught in the spray. They delighted in the beauty of Glendalough and taught us the joy of doing the same by their example."

Glendalough is a place we each can call "our own".

Walk in the Park - 2021 by Tracy Kortlever and Dan Malmstrom

On Saturday, April 24th, park enthusiasts from around the region participated in our 25th annual fundraising event, "Walk for Glendalough" – and many are still walking. Not unlike 2020, we modified our event to be a Self-Guided Walk to comply with the Covid-19 restrictions in place at Minnesota state parks. And similar to 2020, your outpouring of generosity was vibrant and continues at this writing.

Last year, with the onset of Covid-19 in March, our Walk committee did a quick pivot to encourage walking in the park without our traditional public gathering, coffee, lunch, program, and prizes. Although we clearly missed the social element of seeing our park friends, the 2020 Walk generated safe activity and your donations exceeded \$10,671. It was great response in very trying times!

As the 2021 Walk event approached, the Covid-19 restrictions were still very real and the committee announced a well-planned self-guided Walk, complete with t-shirts and free plants, but again without the gathering and program attributes. The park staff did an incredible job of preparing for Earth Day weekend so our families and friends could enjoy Glendalough's pristine setting, wildlife, interpretive qualities, and diverse trail opportunities as spring began to show its new life. To date, we have received nearly \$13,000 in Walk 2021 donations and those funds will be put to great use toward public amenities. The timing of your generosity for these amenities is perfect as Glendalough State Park eclipsed 127,000 visitors in 2020 – a huge growth over the prior year – a stunning trend that has continued since 2014.

Although we usually celebrate all the great things happening in the Park at the Walk, we are working hard to keep you informed in other ways. This newsletter is one avenue, along with articles in the Battle Lake Review. You may also stay informed via the popular Park Partners and Glendalough Trail Facebook pages which often include real-time happenings.

Make your campground reservations early! All weekends within the 120-day reservation window may already be almost booked! You may want to consider camping on a few weekdays instead when the park is less busy.

Megan Hodnefield is our new Park Operations Intern. Her mom worked here as a Parks Worker in 2002. I guess it runs in the family! Three additional new employees will be starting at Glendalough in the next couple of weeks. With only two returning seasonal employees, this the most turnover at Glendalough in many years.

Park Projects

<u>Bike Trail Loop Completion</u> – Engineering will be finalized after wetland delineation takes place this spring. Full funding has been identified! Construction will likely start in 2022.

<u>New Trail Center</u> – Preliminary design is still in progress. A considerable funding gap remains despite Parks and Trails adding an additional \$250,000 to the project. Costs of building materials are skyrocketing.

<u>Annie Battle Lake Boat Access</u> – A re-design of the Annie carry-in access and watercraft storage area is being done concurrently with the trail center design, but no funding has been identified yet. The re-design will take parking off the road, add a drop-off loop, and protect the shoreline from further deterioration. It will remain a carry-in access only.

<u>Boundary Survey</u> – The southwest boundary of the park was surveyed for installation of boundary signage. Some differences with a previous survey are still being worked out, after which the new signs will go up.

<u>Prairie Restoration</u> – Flower seed harvested at Glendalough was delivered to Lake Country Gardens to be grown up into plugs for transplant in Pam's Prairie next fall. Volunteers will be needed to plant in October.

<u>Firewood Bin</u> – A fiberglass roof will be installed on the campground wood bin – no more tarps!

From St. Paul

Glendalough received a lot of attention from statewide media during the Governor's Fishing Opener in Otter Tail County. DNR Commissioner Strommen made a brief visit to the park during the event and expressed a desire to include State Parks and Trails in future GFO events whenever practical. Glendalough may again be setting a trend. Special thanks to our Governor's Fishing Opener volunteers!

Many COVID-19 restrictions on outdoor activities have been removed, and the picnic shelter can now be rented at full capacity. Indoor spaces are still restricted and require masks. The lodge is open daily for one household at a time to view the interpretive video and displays. The dining hall is open for up to six people to use the Wi-Fi, etc. No food or drink is allowed in either building at the present time, except for private rentals (capacity of 6). The office is open daily for limited hours, but for just one household at a time.
